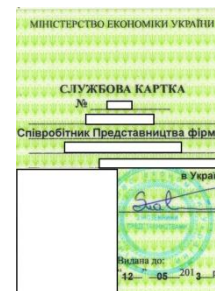

4 - ADVICES

- 1 – Make a **certified translation of your passport** in Ukrainian;
- 2 – Follow carefully **immigration rules**, especially the **new Visa Regulation** (also for expats' families);
- 3 – Remember the **date of expiry** of your passport/visa/documents in order to anticipate procedures;
- 4 – Remember that you can **appeal** any visa issuance refusal/decision of authorities;
